9. **Data Protection Act 2018:**
The Clerk reminded councillors, who hadn't already done so, to return their signed checklists to her.
10. **Report on visit from Lincolnshire Highways: (full report circulated)**
 - **Flooding and Drainage on Rauceby Drove / A153** – Cleaning of soak holes to take place, followed by the installation of a small water alleviation scheme.
 - **30mph sign on Cliffe View** – Highways to reconsider moving this to a more effective position.
 - **Flooding and Drainage on Thorpe Drove** – Highways to consider some low level kerbing and possible extra drainage, utilising a nearby ditch.
 - **Use of North and South Rauceby as by-pass to Holdingham** – Improvement to Holdingham roundabout may be beneficial to the village. Weight limit deemed to be unacceptable and unpoliceable.
 - **Village Signage** – Signs low priority. Pothole repair currently taking precedence.
 - **Village Speed Reduction Scheme** – Red tarmac scheme should be completed in this financial year. The Chairman confirmed that if the red tarmac is sprayed over with new chippings, Highways will replace it at their own cost.
 - **Reporting to LCC and Highways** – New online reporting portal had recently gone live.

11. **Public Footpath update:**

- Cllr Waite had now walked most of the footpaths. Some overgrowth on the path near Glebe Farm, North Rauceby. Cllr Hoare will look into getting it cut.

12. **Correspondence:**

- **Enquiry regarding the reporting of bonfires in the village** – It was agreed that it was not something that the Parish Council could become involved in. Any issues should be reported to Environmental Services at NKDC.
- **District and Parish Elections** – to take place in 2019. Allowance to be made in the budget.
