9 Litter picking in the village:

- Flooding Issues on Rauceby Drove and A153 No response from Cllr R Davies to the email sent in January. The Clerk had pursued the matter and eventually Cllr M Storer had responded, promising to update the Parish Council at the meeting. However, he was not present to do this. It was agreed that a letter be sent to the Leader of the County Council expressing disappointment about the persistent absence of the County Councillor and the increasing safety concerns regarding the flooding issues.
- Room hire at Rauceby Village Hall An invoice had now been received. Unfortunately, the hall
 was again double booked. Cllr Enstone to make enquiries about hiring the room at the school.
